
Subject: **Decentralization of rebate collection for cement and High Density Polythene pipes**

The Dzongkhag Administration hereby notify regarding the decentralization of rebate collection for cement and HDPE pipes for the fiscal year 2021-2022 shall be made by the Spending Agency (Dzongkhag Administration, Bumthang). Any civil works executed either through contract or department which involve Cement and High Density Polythene items are mandatorily to be procured from the nearest sales depot (Penden, Lhaki & Dungsam Cement Agent & Druk pipes and Rabten Pipes).

In this regard, the Dzongkhag Procurement Office would like to request all the Gewog Administration Officers and Concerned Engineers to kindly assist us to submit quarterly report for all the capital activities.

Hence, the procuring agency must clearly specify in the specification section of the bidding documents the use cement and HDPE pipes from the authorized dealership. The copy of notification issued by Department of National Properties vide MoF/DNP/PPD/Notification/2021/3015 dated 27th December 2021 is attached for kind information and necessary compliance.

NOTIFICATION

Sub: Decentralization of rebates collection for Cements and High Density Polyethylene(HDPE) Pipes

This is to notify all the Budgetary Bodies that the rebate collection for procurement of cements and HDPE Pipes is hereby decentralized to the Spending Agencies with the objectives to:

- Achieve higher rate of compliance by all procuring agencies;
- Avoid persistent problem of incomplete reports from procuring agencies;
- Plug the revenue leakage by collection at source.

In this regard, following procedures is prescribed for rebates collections:

- Every Spending Agency carrying out civil works (*either through contracts or departmental works*) which involves cement consumption and water supply works/irrigation works/plumbing works which involves consumption of HDPE pipes shall clearly specify in the specification section of bidding documents the use of Penden Cement /Lhaki Cement/Dungsam Cement and Druk Pipes/Rabten Pipes which should be lifted from the nearest sales depot.
- Each time the contractor lifts the Cement and HDPE pipes, a letter shall be issued by the Spending Agency to the depot manager specifying the price and quantity of Cement and HDPE pipes to be lifted for each consignment.
- The letter issued by the Spending Agency shall be produced by the contractor to the Depot Manager during the purchase of cement and HDPE pipes for each consignment. The Contractor shall submit the invoice copies to the Spending Agency.

- iv. All Geog Administration and Dungkhag Administration awarding work shall submit at the end of every month a report of Cement and HDPE pipes purchased for the government construction works (*both contractual and departmentally executed*) with invoice number and dates to the Dzongkhag Administration for compilation and collection of rebates offered by the Manufacturers;
- v. All regional office¹s shall submit at the end of every month a report of Cements and HDPE pipes procured by contractors or their offices to their respective Departments for compilation and rebate collection. Similarly, autonomous agencies shall submit at the end of every month a report of Cements and HDPE pipes procured by contractors or their offices to their Higher Autonomous Bodies for compilation and rebate collection. The Ministries shall compile monthly consumption of cements and HDPE pipes by their offices and collect rebates from manufacturers;
- vi. The Head of Agencies shall appoint Procurement Officer (*relevant officer in absence of procurement officer*) as focal officer for compilation and collection of rebates from the Manufacturers;
- vii. The collection of rebates from the manufacturers shall be done on a quarterly basis based on the consumption reports compiled by the agencies and deposit it into the Government Revenue Account using Revenue Administration Information Management System (RAMIS).
- viii. DNP shall circulate rebate agreements executed with the manufacturers to all rebate collecting agencies for compliance.

¹ Regional Offices include Regional Revenue & Customs Offices, Regional Offices, DoR, Regional Trade Offices, Regional Immigration Offices, Regional RSTA Offices, all offices under MoAF and all other Regional Offices executing government-budgeted activities








REBATE COLLECTION PROCESS FLOW CHART


