

Terms and Condition

1. All the bidders shall pay Nu.300.00 (Three hundred) only as entrance fee, which shall be non-refundable.
2. Any representative/s can register and avail a token behalf of the interested bidder/s.
3. Each bidder shall deposit the earnest money of Nu.5000 (Five thousand) only in cash to Government Revenue Account before a week before the auction to qualify him/her to bid for the auction. On receipt of the earnest money, a token shall be issued to identify the qualified bidder. A person without a token shall not be allowed to bid for enlisted lot/s.
4. The prospective bidder shall not allowed to inspect the lots on the same day of the public auction.
5. The earnest money of the topmost winning bidder shall be retained until the auction is completed as a security for subsequent bids to be offered in respect to the remaining items. On completion of the auction, the earnest money of the topmost winning bidder shall be adjusted against the auction value of items won by the respective bidder. However, the earnest money of unsuccessful bidders shall be refunded on the same date only upon completion of the public auction.
6. The topmost winning bidder, whose bids are accepted, shall deposit a spot payment of 25% (in cash or mBoB) against the auction value at the fall of the hammer.
7. The balance 75% of the auction value shall be paid within 10(Ten) working days from the day of the auction before 4PM. The winning bidder has the option to make the 75% payment in the form of cash or demand draft in the favor of Dasho Dzongdag, Dzongkhag Administration, Bumthang from any reputed financial institutions. Failure to pay within stipulated days or time, the accepted bid shall be cancelled and deposit of 25% of auction value shall be forfeited.
8. Failure to lift/deliver on the stipulated day shall result in the forfeiture of 25% deposit of the auction value shall be forfeited.
9. In regards to the dismantling of structure, the topmost winning bidders shall lift within 1 month (ONE MONTH) from the date of auction. In the event of full payment to Dzongkhag Administration, if such items are not lifted within the stipulated days shall result in forfeiture of the 25% deposits of the auction value and same shall be in the next auction.
10. The successful bidders for dismantling works shall have to make a security deposit of 20% of the bid value, (in Demand Draft drawn in favor of Dasho Dzongdag, Dzongkhag Administration, Bumthang)which shall be refunded after the completion of dismantling works and subject to a letter of successful completion being provided by the Dzongkhag. The dismantling work include the demolition of the structure, lifting of the materials and clearing the debris of the area. The duration of the work shall be one month from the day of issuance of work order.
11. The auction committee reserves the right to accept the bids on the spot or at any subsequence date. In case of any dispute or problem with regard to the auction, the decision of the committee shall be final and binding.
12. The perspective bidders are mandated to inspect the lot/s prior to the public auction. Therefore, the bid offered is at their own liberty and judgment. No complaint will be entertained at a later date.

INSTRUCTION TO THE BIDDER

The Tender shall be submitted in accordance with these instruction and tenders not confirming to the instruction as under are liable to be rejected. These instruction shall form part of the tender and contract documents.

1. The Tender form should be submitted in **sealed envelope** superscripted as “ **Bid for compensated structures**”
2. The Tender form should be submitted along with Earnest Money Deposit(EMD) amounting to 25% of the quoted value through Demand Draft in favour of Dasho Dzongda, Dzongkhag Administration, Bumthang.
3. The Tender documents must be signed on each page by the bidder/authorized representative as a token of acceptance of the terms and condition laid down in the tender documents.
4. The offer rate shall be quoted as per the format attached as annexure **DJ** and C and the currency in the bid shall be quoted in Ngultrums.
5. The auction is on “As is where is basis” and the bidder(s) shall have to ascertain and get satisfied with the conditions of the auction items before the participation and no complaints shall be entertained after submitting the bid(s).
6. The interested bidder(s) must inspect the items to his/her full satisfaction and no complaints shall be entertained after submitting the bid(s)
7. Bids shall be opened in the presence of the bidders/authorized representatives.
8. The Tender documents must be submitted in original and tender documents received through email or photocopied shall not be accepted under any circumstances.
9. The highest bidder (successful bidder) must deposit the full amount within 10 working days and must lift the materials from the site (as where is basis) within 30 days after the notice of award. Failure to do so will result in forfeiture of his/her EMD followed by awarding the items to the second highest bidder.
10. The bidders shall not be allowed to lift the items in part without making the full payment.
